Estimated match times:	Bambinos / Pupil 3 x 1 min – 30 seconds rest Cadet / Junior / Senior 3 x 1 min 30 sec – 30 seconds rest
Competition mode:	K.O. System, WT - Rules (changes are possible)
Equipment:	Sensor socks from Daedo (including heel sensor) are compulsory and must be brought by the contestants.
Awards:	Medals for 1st, 2nd and 3rd place single contest for Senior, Junior, Cadet Cups or Medals for 1st, 2nd and 3rd place for single contest for Pupils, Bambinos Cups for 1st till 10th place for team contest + Challenge cup
Sport hall rules:	The access for fighters and coaches is only allowed with Dobok and track suit (no black shoe sole). The organizer and president don't take any responsibility for injuries or any kind of damages.

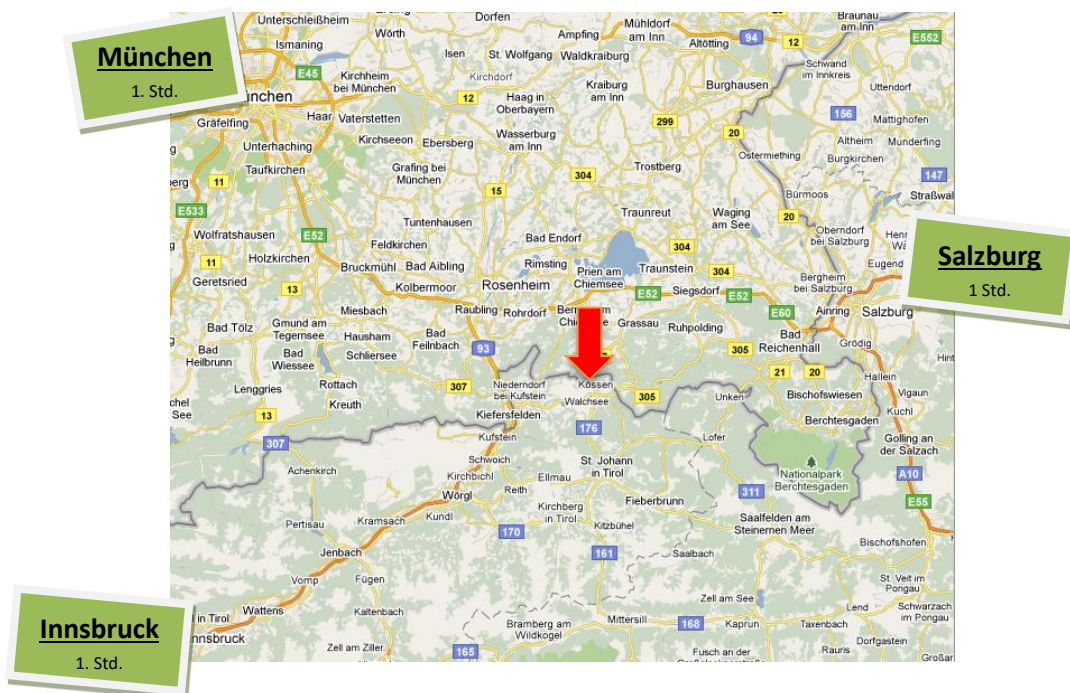
