1. all disputes arising in connection with the anti-doping regulations applicable to the German Taekwondo Union e.V. (World Anti-Doping Code "WADC", National Anti-Doping Code "NADC" and anti-doping regulations of the World Taekwondo and of the German Taekwondo Union e.V., in particular regarding the validity and application of these anti-doping regulations, are shall be settled in the first instance by the German Court of Arbitration for Sport of the German Institution of Arbitration (Deutsche Institution für Schiedsgerichtsbarkeit e.V (DIS) in accordance with the DIS Sports Arbitration Rules (DIS-SportSchO) and the procedural provisions of the Anti-Doping Rules, in particular the anti-doping regulations, in particular Art. 12 and Art. 13 of the German Taekwondo Union's Anti-Doping Regulations. This also applies to disputes concerning interim legal protection.
2. the German Court of Arbitration for Sport is authorized to impose sanctions for violations of applicable anti-doping rules.
3. the German Taekwondo Union e.V. has transferred the implementation of results management and the right to initiate disciplinary proceedings in anti-doping matters to the German National Anti-Doping Agency (NADA). The parties to this Arbitration Agreement recognize that NADA may directly file an arbitration claim against the Athlete and become a party to any such arbitration proceedings.
4. arbitral awards of the German Court of Arbitration for Sport may be appealed to the Court of Arbitration for Sport (CAS) in Lausanne in accordance with § 61 DIS-SportSchO, Art. 13 of the Anti-Doping Regulations of the German Taekwondo Union e.V. and Articles R47ff of the Code of Sports-related Arbitration (CAS Code). The parties to this arbitration agreement recognize that NADA, the World Anti-Doping Agency (WADA), World Taekwondo and the other organizations listed in Article 13.2.3 of the Anti-Doping ing Regulations of the German Taekwondo Union e.V. can lodge a direct appeal and thus become a party to the appeal proceedings themselves and thereby become a party to the appeal proceedings before the CAS.
- 5 This arbitration agreement has been in force since 01.01.2020.
