## 2. PLACE AND DATE

- 2.1 Place: Eindhoven, Indoor Sportcentrum Eindhoven  
Theo Koomenlaan 1, NL-5644 HZ Eindhoven
- 2.2 Date: Saturday 19th of October 2024 (senior categories)  
Sunday 20th of October 2024 (junior & cadet categories)



## 3. CONTESTANTS

- 3.1 Categories:** Seniors 17 Year and older  
Juniors 15 – 17 years  
Cadet 12-14 years

Athletes can only participate in 1 category

- 3.2 Age:** According to WT-categories.  
Senior competitors: Born in 2007 and older  
Junior competitors : born in 2007, 2008 and 2009  
Cadet competitors : born in 2010, 2011 and 2012

- 3.3 Graduation:** All competitors must hold at least 2nd Geup.

- 3.4 Weight divisions:** World Taekwondo weight classes

- 3.5 Qualifications:** Participants must be member of a National Taekwondo Federation, affiliated to WT. A valid 2024 and applicable WT Global License is required for all athletes and officials participating in this tournament.  
There will be "NO" WT Global License registration onsite  
Coaching requires also a valid WT coach Level 1 or higher.





## 4. RULES

- 4.1 OVR system:** Martial.Events
- 4.2 IVR system:** Will be used on all competition areas. 1 quota for each match.
- 4.3 Competition rules:** WT Competition rules.
- 4.4 Competition mode:** Single elimination tournament system.
- 4.5 Contest time:** Best of three (3) system will be used.  
Seniors 3 x 2 min, 1 min break between each round  
Juniors and Cadets 3 x 1,5 min, 1 min break between each round  
*The TD has the authority to adjust the contest time*
- 4.6 Doping Control:** Some contestants chosen at random will be tested
- 4.7 Hall Rules:** Only the competitors and their coaches (1 per competitor) will have admittance with valid accreditations to the contest areas
- 4.8 Equipment:** PSS + E-helmet shall be provided for all categories.  
Contestants must bring their own protectors (groin, forearm, shin, mouthpiece, gloves) and Daedo sensor socks.  
Only WT-recognized equipment is allowed.
- 4.9 Protest:** Only the official coach is allowed to protest. This must be done immediately after the end of the contest. An amount of € 100,- will have to be paid for each protest. The protest amount will not be refunded in any case.
- 4.10 Liability:** All competitors participate at their own risk. The organization shall not accept responsibility for any damages, violence, injuries or losses. Specifically note that they also take no responsibility for consequences due to (directly or indirectly) acts or threats of terrorism and COVID-19 (or likewise). All contestants must bring their own documents and forms for any medical treatment in the Netherlands. If not, this will have to be paid in cash.



**4.11 Liability waiver:** Those who are not recognized as adults (under aged) by law in their own country must submit a passport or identification card together with a written consent (declaration of consent) at registration signed by parents or lawful guardians, accepting the participation and all parts of the official invitation.

**4.12 Identification:** According to Dutch law all competitors and visitors need to have a valid Identification by means of a valid passport or other official identification document.

**5.4 Accreditations:** National teams are allowed to have accreditations for 1 MNA official, 1 official doctor and 1 coach for every 4 competitors. Club teams are only allowed to register coach accreditations.

For every 4 competitors 1 coach is granted free admission. Extra coach passes can be requested separately for € 25,00 for each individual coach. A valid WT coach license is obligatory.

Accreditation change will be charged € 25,00

**5.5 Modifications** Modifications (only weight changes) are possible at the registration for an amount of € 25,00  
After attending the official weigh-in no further modifications are allowed. This means no further changes will be made in weight divisions! Competitors who started the official weigh-in procedure must complete this, if not completed, the competitor will be disqualified from the competition. Restitutions will never be made.



## IMPORTANT

If an athlete who is registered on <https://worldtkd.simplycompete.com/events> does not take part in the competition, but he/she has not been removed from the list of participants before the deadline, the team or official must fully (100%) pay his/her entry fee for participation.

**Entry fee is not refundable at any time after the deadline!**

- 5.6 Procedure:** Payments must be received within 3 days of the registration. If payment is not received within 3 days, the organization has the right to remove the entry from the online registration. Entries done 3 days before the deadline must be paid immediately.

- 5.8 Payment:** Must be done by TEAM. Individual payment is not allowed. Restitution will never be made.

**Late bird** € 175 for each competitor via bank transfer paid between 28 September and 18 October

**10. VISA:**

The ministry of foreign affairs of the Netherlands advises that those participants which need VISA for entry into the Netherland should apply for visa at least one (1) month before arrival in the Netherlands, I.C. Before the 18th of September 2024.

**11. OTHERS:**

Recording within the competition area is not allowed. Recording from the public stands is only allowed with handy can-type cameras..

Commercial business is not allowed under any circumstances without any written permission of the Dutch Taekwondo Federation. Only contracted business is allowed in the venue. A penalty of € 10.000,- shall have to be paid in cash when violating this rule. The organization will have full authority to remove the violators from the venue and event. Please note that you will automatically comply with these rules written in this invitation when accessing the venue or any part of the event.

Press: Due to safety reasons it is not allowed for press to make pictures inside the field of play. Accreditation for official press is allowed but will not be allowed inside the field of play.

GDPR: All visitors inside the venue, including athletes and officials, are agreed to be filmed, photographed at any time. All event data will be used for our social channels and exposure of the Dutch Open Taekwondo Championships.
